Coir Board participated in the Maha Shivarathri Mela at Mandi in Himachal Pradesh on 23.02.2012 for popularizing Coir and Coir products. Chairman, Coir Board emphasized the speciality of Coir, the versatile natural golden fibre, which keeps warmth in winter and coolness during the extreme summer. He interacted with the Managing Director of Himachal Pradesh Handicrafts & Handloom Corporation Ltd., Shimla for marketing of Coir and Coir products through the sales outlets on commission basis.
