The Important Events/discussions/decisions pertaining to Coir Board for the month of January **2015** are furnished below.

INTELLECTUAL PROPERTY FACILITATION CENTRE

In order to encourage and legally protect the intellectual property rights in the coir sector at the national and international level, a proposal for setting up of Intellectual Property Facilitation Centre for MSME under Intellectual Property Rights- National Manufacturing Competitiveness Programme scheme at Central Coir Research Institute, Kalavoor, Alleppey has been forwarded to office of the Development Commissioner, Ministry of MSME.

PUBLIC OUTREACH

Coir Board has been informing about all important activities through social media channels viz. Face Book and Twitter in addition to the normal website of the Coir Board and its field offices. The response has been quiet encouraging with the Face Book and Twitter having attracted over many followers. Coir Board has also a Help Line (Toll Free NO.1800-4259091).

Coir awareness movies have been uploaded in the You tube.

Coir Board has revamped a credit linked subsidy scheme Coir Udyami Yojana with the capital out lay of Rs.80 crores for setting up of 2750 units during the 12th plan period. A gist of the scheme for inclusion in the **"Mann Ki Baat"** programme of the Hon'ble Prime Minister of India is attached as Annexure.

M/s.BSCIC Certifications Pvt Ltd has conducted their assessment for granting ISO 9001:2008 on 9th January, 2015 at Coir Board Head Office. After assessment, it has been reported that he Coir Board Head Office has been found to be operating a Quality Management System which complies with the requirements of ISO 9001:2008. Accordingly, Coir Board Head Office will be granted ISO 9001:2008 certificate, shortly.

Coir Board is in the final stage of introduction of e-office.

Coir Board has initiated action to introduce Aadhar based attendance biometric system for all employees.

On the basis of budget announcement by the Finance Minister for setting up a nationwide district level incubation and accelerated programme in MSME sector for incubation in new ideas and providing necessary support for accelerating entrepreneurship, Coir Board has forwarded a proposal to the DC,MSME to set up seven technology incubation centres all over India at a total financial outlay of Rs.14 crores under capital expenditure, at the following places:

S&T ACTIVITIES

ANNEXURE

1. The Scheme would cover any coir project with project cost upto Rs.10 lakhs plus working capital, which shall not exceed 25% of the project cost. The working capital shall not be considered for subsidy. The quantum and nature of financial assistance under the scheme will be 40% of the project cost as Government of India subsidy, 55% as Bank credit and 5% as beneficiary contribution.

2. The assistance will be made available through all Scheduled Commercial Banks listed in the 2nd Schedule of the RBI Act, Regional Rural Banks, Co-operative Banks, SC/ST/OBC Finance and Development Corporations.

3. Individuals, Companies, Self Help Groups, Non Governmental Organizations, Institutions registered under Societies' Registration Act 1860, Production Co-operative Societies, Joint Liability Groups and Charitable Trusts can avail assistance under the Scheme.

4. The beneficiaries shall have the option to purchase machinery from any reputed manufacturer or fabricator of coir machinery from the open market. However, the coir machinery/accessories purchased from the manufacturer must comply with the standards set up by the Coir Board from time to time. Beneficiaries have the option to consider purchase of generator in order to get full utilization of the machinery purchased.

5. With a view to provide handholding support towards the marketing efforts of the Coir Udyami Yojana beneficiaries, an allocation of Rs.10 Crores has been earmarked as Marketing Support Assistance under the Scheme. The assistance will be disbursed for establishing Marketing Consortiums, participation in fairs/exhibitions, hiring of showroom/go down etc.

6. Coir Board, Coir House, M.G.Road, Kochi-16 is the Nodal Agency at the national level for implementation of the Scheme. At the state level the scheme will be implemented through the Field Offices of the Board viz. Regional Offices/Sub Regional Offices/Coir Mark Scheme Office/Showroom & Sales Depots and all other sub offices of the Coir Board situated in different parts of the country. The Field Offices of the Board will coordinate with DICs, Coir Project Offices, Panchayat Raj Institutions and other NGOs of repute and such others for the identification of the beneficiaries under the Scheme.
