महत्वपूर्ण घटनाएँ/Significant Events

1. A team of higher officials from Andaman and Nicobar Islands Integrated Development Corporation Limited (ANIIDCO), Port Blair, Andaman & Nicobar Islands visited Coir Board on 3rd May 2019 at the Board Room, Coir Board Head Quarters, Kochi. A meeting has been convened by the Board alongwith Coconut Development Board, Kochi regarding the setting up of Coconut and Coir Processing units at Andaman & Nicobar Islands. The meeting was attended by Shri.Kulanand Joshi IAS, MD, ANIIDCO, Shri.Krishan Kumar IAS, Secretary, Agriculture & Rural development, Shri. Ajith Anand, Director of Industries, Shri.Mohd. Pervaiz, GM(Project), ANIIDCO from Andaman and Nicobar Islands, Shri M Kumararaja, Secretary, Coir Board and other higher officials from Coir Board and Coconut Development Board.

 Coir Board represented at the TXD 09 meeting of Bureau of Indian Standards at New Delhi on 15.05.2019. In the meeting a detailed discussions were made for the implementation of the Ecomark criteria in all the published standards of coir and agreed to amend the IS 1410:2001 Textiles-- Coir Ropes – Specifications to include the additional requirements for * Ecomark. It was also decided to issue similar amendments to IS 16338:2015 fibre ropes –

Coir Teine for trailing hop vines and be published as 2019 version.

- Shri. P Abdul Samad, the Director of Industries, Lakshadweep visited Central Coir Research Institute, Kalavoor, Alappuzha on 02.05.2019.
- A team of horticulturists and farmers from Nagaland visited Central Coir Research Institute, Kalavoor, Alappuzha on 02.05.2019.
- 5. To review the progress of implementation of 12 SFURTI Coir clusters in Kerala (Neyyattinkara, Balussery, Haripad), Karnataka (Tumkur, Kumta, Haralakatta), Gujarat (Samvedana, Tarapur), Maharashtra (Pendur, Sawantwadi) and Andhra Pradesh (Chittoor, Vizianagaram) were held on 06.05.2019 at Coir Board H.O. Kochi. The meeting was chaired by Shri. M.Kumara Raja, Secretary, Coir Board. In the meeting, prime focus was given to the Swatchh Bharath activities for the year 2019-20. It has also been decided that those clusters which are in the final stage of scheme implementation must complete all the pending Soft and Hard Interventions within 31.08.2019 and all the newly approved clusters should complete the activities within 31.01.2020.
- 6. In order to implement the action plan for Swachh Bharath activities by Coir Board during the current fiscal year, action plan has been prepared for implementation of various activities at a sanctioned amount of Rs.50 lakhs. However the action plan envisages some additional activities also at an estimated amount of Rs.2.94 Crore totally subject to the availability of additional fund from the Ministry. Action is underway for the celebration of Swachhta Pakhwada from 16th 30th June 2019.
